

ONLINE PRIVACY POLICY AGREEMENT

Collection of Information

- Remain in conformance with any decrees, laws and/or statutes or in an effort to comply with any process which may be served upon Montana Natural History Center and/or our website;
- Maintain, safeguard and/or preserve all the rights and/or property of Montana Natural History Center; and
- Perform under demanding conditions in an effort to safeguard the personal safety of users of Montananaturalist.org and/or the general public.
